- This committee meets on the 2nd Tues of each month at 5:30. Generally they are approximately 1 hour, but we do schedule ad hoc additional meetings when needed.
- The mission of the committee is an advisory role to the Board of Directors (and indirectly various other committees and POA staff) on issues relating to compliance which could include topics such as:
  - Maintenance Standards on the Island
  - Evolution of Compliance Inspector's roles and responsibilities
  - Gaining cooperation by property owners to compliance standards
  - How to gain constructive feedback from the community we serve regarding their desires for compliance within the POA Guidelines.
- The committee is responsible for not only identifying issues, but also providing possible solutions that could be reasonably implemented. At times the committee (or some members from the committee) may also become part of a solution team if the board so desires.
- **It is imperative that members of this committee represent a broad range of citizens from the community with varying opinions.**
- **It is mandated that committee members display respect and courtesy to all members of the committee, listen to all ideas brought forth, and agree to work in a cooperative manner to help provide alternate solutions. The committee will not be addressing "individual situations," rather it will tackle issues that relate to the community.**
