1. Call to order

3. Approval of Meeting Minutes

4. ACC Applicants

- a. In attendance to be considered for ACC positions were Jo Allsopp, Charlie Guzman and Ernest Nuckols. All three candidates were interviewed regarding their interest in being part of the ACC:
 - i. <u>Jo Allsopp</u> It was disclosed that Peter Allsopp, Mrs. Allsopp's husband, is a compliance officer for the PIPOA. The ACC questioned whether that could be seen as a conflict of interest given the crossover with construction site quality standards. The ACC tabled for further discussion and review of Mrs. Allsopp's qualifications.
 - ii. Charlie Guzman Mr. Guzman has extensive construction experience, going back to 1986, including new home and renovation construction. He understands hurricane wind requirements and regulations and is familiar with requirements and issues with construction in the PIPOA. There was a concern that, while married to property owner Kim Erwin, Mr. Guzman does not own property on the Island. This was tabled for later discussion. UPDATE: Mr. Guzman stated he owns property on the Island 102 Mystic Harbor (14428 Compass Street), under CLG & Associations, LLC. The question was raised whether a condo owner within an HOA, while part of the PIPOA, can serve on the ACC or other boards within the PIPOA. The discussion has been pushed to the PIPOA BODs for review.
 - iii. <u>Ernest Nuckols</u> Dr. Nuckols has lived on the island for 30 years. He wants to be on the ACC to have influence on things that happen and provide input. He believes that the ACC should mitigate decisions based on how it affects others, calling it "it's a dance". UPDATE: On Tuesday, August 11th, Dr. Nucklos rescinded his application and willingness to be on the ACC. He forwarded an email to Heather Cooley withdrawing his name from consideration.
