**Executive Director Jim Smock provided updates on the following:** 

- Office will close at 2:30pm on Wed so that staff can attend the memorial service for Kathy's husband.
- An investigation of the discrimination accusations made at last month's meeting was done. Attempts were made to contact specified parties. Jim was unable to verify any of the accusations.
- Research for the new software systems is continuing.
- He continues his request for decorum online and in person when dealing with the office staff. He said interactions have improved.
- A contract is in place to repair the Cobo De Bara boat ramp parking lot.
- A contract is in place for regular canal cleaning.
- Late statements have been generated and late fees have been applied. Since the last meeting, over \$78,000 of late CAM fees have been collected. Reiteration of the need for an official collection policy.
