#### Hello All:

Just an update re ISAC. Attached below is the correspondence re the last meeting including Minutes from the meeting of 4/8/19 (which were approved).

My notes from May 7, 2019, are below:

Public comment (Rebecca Hargrove)- request for Life rings at beach.

Planning Dept.- 9-12 mo's. before any project on Island will start.

Watershore and Beaches- discussion re changing ordinance requiring kite boarders to stay 50' from other people on beach to increase that distance.

Water Control- Harbor Bond will be reimbursed by FEMA.

Parks and Rec.- Problems with Riley P. Dog Park; not a Park project, but rather Wastewater project; nobody at city responding to Jan Rankin. Parks Dept will try to address. Also, waiting for estimates re splash pads; will make recommendation re where splash pads will be placed; Isac member Jay Gardner suggested Riley P. Dog Park.

Beach Super- Adding three more lifeguard stands this year (total of 8). Just got buoys installed near boat launch. Discussion re using jet skis more often during emergencies; discussion re budgeting for more lifeguards; lifeguards are currently practicing/training.

#### **Engineering Updates-**

- 1) Beach Facility- ready to build, but still waiting for decision re site (issues: safety; aesthetics; value).
- Beach Access- Newport and Zahn project under design.
- 3) Park Rd. 22- Discussion re AXYS and IBC waiting for City to move forward; City waiting for AXYS and IBC. Parties present agreed to track down docs, and communicate re moving forward.
- 4) Packery Channel Rehab- design is under review; meetings with FEMA took place.
- 5) Packery Monitoring Contract- City getting third party consulting company to provide recommendation re how often monitoring should take place.
- 6) Packery Channel Boat Launch Pavillion- low bid was over budget, so working to revise design and/or award more funds.
- 7) Packery Channel Showers- Hybrid project between City and County; 3 weeks until issue will come before Commissioner's Court.
